Background

Health and Safety Code Section 34186(c) requires successor agencies to submit to the county auditor-controller for review, the differences between actual payments and past estimated obligations on a Recognized Obligation Payment Schedule (ROPS). This process is referred to as the Prior Period Adjustment (PPA). The Sacramento County Auditor-Controller requested the 2017-2018 PPA from all Sacramento County successor agencies on December 19, 2019. The Auditor-Controller also requested documentation of actual expenses (invoices, time records, etc.) from all Sacramento County successor agencies as part of that review.

Following the Sacramento Countywide Oversight Board hearing on January 6, 2020, several members of the Oversight Board requested to see the latest available documentation for administrative costs. Auditor-Controller Division staff have prepared a breakdown of administration costs for each successor agency for Fiscal Year (FY) 2017-2018 in response to this request.

Discussion

Attachment 1 contains a detailed breakdown of administration costs and items with authorized payments and associated administrative activity for each successor agency. The City of Isleton Successor Agency did not submit any information as required by law and we therefore have no information to present. In addition, the City of Galt Successor Agency and the City of Folsom Successor Agency provided budgeted amounts instead of actual costs, so budgeted amounts are presented for these successor agencies.
